

TERMS & CONDITIONS:

These terms and conditions of registration apply to TCT® Plus Middle East 2025 (the “conference”) and are subject to change by the organizers. Additional terms and conditions can be found on the official conference website and are incorporated into these registration terms and conditions. As the organizer of the conference, KR will strictly enforce these terms and conditions of registration.

1. Information Verification

- You certify that all of the information provided by you in connection with your registration for the conference is true and accurate. Violation of this policy may result in you being banned from attending or participating at the conference and/or any future KR sponsored/-managed events. All registration information may be subject to further verification by KR. KR will reach out directly should additional information be needed.

2. Registration Fees

- All registration fees must be paid in full at the time of registration. Any unpaid registrations may result in the loss of your spot at the conference or the higher registration rate.
- Prices are as listed on the official event registration page and are subject to change without notice prior to your registration being confirmed.
- Special discounts, if any, must be claimed during the registration process and cannot be applied retroactively.

3. Verification of Registration Types

- By registering for a registration type (e.g., fellow, physician, industry, etc.), you certify that you meet the definition of that registration type. Definitions of each registration type can be found on the conference specific website.
- KR will reach out directly should additional information be needed to verify your registration information.
- KR reserves the right to cancel any badges who are found to not meet the definitions without refund.
- KR reserves the right to re-assign the registration category and issue any balance due without prior notice if the selected category and fee do not match, or if the information provided does not qualify the registrant for the chosen category.
- Incorrect or inaccurate registrations will not be refunded, and violation of this policy may result in you being banned from attending or participating at the conference and/or any future KR, CRF or HeartLinks sponsored/-managed events.

4. Cancellation Policy

- All cancellation requests must be submitted in writing via email to info@kr.net.sa.
- **Cancellations more than 8 weeks before the event** (before Thursday, February 20, 2025, 11:59 PM): A full refund may be issued, minus a processing/administrative fee (3.2% SAR), or as determined by the event organizers.

- **Cancellations more than 2 weeks before the event** (between Friday, February 21, 2025 and Wednesday, April 2, 2025, 11:59 PM): A 50% refund may be issued, minus a processing/administrative fee, or as determined by the event organizers.
- **Cancellations within 2 weeks of the event** (on or after Thursday, April 3, 2025, 12:00 AM): No refunds will be provided for cancellations made within this period.
- **Non-attendance:** Failure to attend the event without prior cancellation will result in no refund.

5. **Substitutions**

- If you are unable to attend, a substitution may be made at no extra charge for individuals of the same registration category (example: only a physician may be replaced with a physician).
- All substitutions must be communicated in writing at least 7 days prior to the event (Thursday, April 9, 2025 by 11:59 PM) by emailing info@kr.net.sa. No substitutions will be accepted after this time.
- The substituted attendee must meet the same eligibility criteria and will be subject to the same terms and conditions as the original registrant.

6. **Event Changes**

- TCT® Middle East reserves the right to modify the event program, including speakers, topics, and scheduling, without notice.
- In the unlikely event of event cancellation by TCT® Middle East due to unforeseen circumstances, a full refund of the registration fees will be issued. However, TCT® Middle East will not be responsible for any additional costs incurred by the registrant, such as travel or accommodation.

7. **Loss of Badge Credentials**

- The organizers reserve the rights to revoke or deny attendance of any registered participant, faculty/speaker, exhibitor, or media at the conference.
